**PERMISSION SLIP**

Dear Parent:

This is to inform you that **CMIT South Students** will be taking a Field Trip to **Air and Space Museum, Chantilly, VA** on **November 21, 2017**. **Students will learn about air traffic control systems and engage in challenges to “line up” the planes safely, with proper spacing, on time, at a given intersection of jet routes. Students compare experiences of early airplane passengers with those of today's passengers and speculate on what the next 50 years will bring.**

Students intending to participate in said field trip are expected to assemble at the school by **8:20am**. Students will be back **no later than 3:00 pm**. Students will call home when we are about to leave Virginia.

Transportation will be provided by a commercial carrier. The commercial carrier will be **Dillon Bus Company**.

The cost for each participating student is **\$15.00** to cover transportation which will be collected from **November 6,8,&9, 2017**. Students will also need pocket cash for lunch should they choose to purchase lunch or bring a bagged lunch. Student who will need bagged cafeteria lunch should indicate so that they can be prepared.

**REQUIREMENTS TO ATTEND**

**MUST NOT HAVE LOST MORE THAN 15 SIS POINTS BETWEEN OCTOBER 3, 2017 AND NOVEMBER 3, 2017.**

**NO LEVEL III OR IV DISCIPLINARY VIOLATIONS DURING THE PERIOD PRIOR TO THE TRIP**

**MUST WEAR OXFORD SHIRT FOR THE TRIP (no refund will be issued if the students cannot go on the trip due to uniform violation)**

**MUST PAY THE ABOVE AMOUNT, IN FULL, BY NOVEMBER 9, 2017.**

You should also be advised that this payment is non-refundable if your son/daughter cancels the trip participation and no substitute student can be found to take and pay for said trip in his/her place. Parent must chaperone students ineligible due to SIS points but would like to go.

Furthermore, please be informed that it is the policy of the Board of Education of Prince George’s County that no student is denied the opportunity to participate in a Field Trip for reasons of inability to pay. Accordingly, if you desire to have your son/daughter participate in said Field Trip but are unable to pay please call the school at your earliest opportunity.
