This is to inform you that CMIT South Students will be taking a Field Trip to **Hershey Park, Hershey PA** on **June 14, 2018**. **Students will apply their knowledge of machines and Newton's law to complete activities at the park.** The field trip seats are on a first come, first serve basis. We have 200 student seats available.

Students intending to participate in said field trip are expected to assemble at the school by **6:00am**. Students will be back, traffic permitting, **no later than 6:00 pm**. Students will call home when we are about to leave Hershey.

Transportation will be provided by a commercial carrier. The commercial carrier will be **Dillon Bus Company**.

The cost for each participating student is **\$75.00 EXACT CHANGE PLEASE** to cover transportation and ticket which will be collected on May 29th and May 30th.

SPECIAL NOTES:

- **Exact change and the paper permission slip must be submitted together to secure field trip spot.**
- **Separate emails will not be able to serve as permission slips.**
- **Money orders and or checks can only be made to CMIT SOUTH.**
- **Money and permission slips will ONLY be collected during lunch.**

Students will need ample cash money for lunch or bring a bagged lunches from home. Bagged cafeteria lunches will not be available as the kitchen will be closed at the time of departure.

REQUIREMENTS TO ATTEND

MUST NOT HAVE LOST MORE THAN 15 SIS POINTS BETWEEN PERIOD SPECIFIED (4/25/18 - 5/25/18).

NO LEVEL III OR IV DISCIPLINARY VIOLATIONS DURING THE PERIOD PRIOR TO THE TRIP.

MUST WEAR GYM/POLO UNIFORM(no refund will be issued if the students cannot go on the trip due to uniform violation).

MUST PAY THE ABOVE AMOUNT IN FULL BY DUE DATES (5/29/18 or 5/30/18).

You should also be advised that this payment is non-refundable if your son/daughter cancels the trip participation and no substitute student can be found to take and pay for said trip in his/her place. Parent must chaperone students ineligible due to SIS points but would like to go. Any level III or IV discipline violation will lead to forfeiture of seat paid for and monies paid will be refunded.

Furthermore, please be informed that it is the policy of the Board of Education of Prince George's County that no student is denied the opportunity to participate in a Field Trip for reasons of inability to pay. Accordingly, if you desire to have your son/daughter participate in said Field Trip but are unable to pay please call the school at your earliest opportunity.
