This is to inform you that CMIT South Students will be taking a Field Trip to the Hispanic Gala Theatre, Washington, D.C. on October 5, 2018. Students will attend a theatre performance titled "Como agua para Chocolate". Students will develop an oral report about this performance. The field trip seats are on a first come, first serve basis. We have 150 student seats available.

Students intending to participate in said field trip are expected to assemble at the school by 8:20am. Students will be back no later than 3:00 pm. Students will call home when we are about to leave Washington, DC.

Transportation will be provided by a commercial carrier. The commercial carrier will be Dillon Bus Company.

The cost for each participating student is \$30.00 to cover transportation which will be collected from October 1st, 2nd, & 3rd, 2018. Payments for the field trip can be made via cash, check or money order (made out to CMIT South). Please send exact change if possible. Students will also need pocket cash for lunch should they choose to purchase lunch or bring a bagged lunch. Student who will need bagged cafeteria lunch should indicate so that they can be prepared.

**REQUIREMENTS TO ATTEND**

**MUST NOT HAVE LOST MORE THAN 15 SIS POINTS BETWEEN SEPTEMBER 4, 2018 AND SEPTEMBER 28, 2018.**

**NO LEVEL III OR IV DISCIPLINARY VIOLATIONS DURING THE PERIOD PRIOR TO THE TRIP**

**MUST WEAR OXFORD SHIRT AND UNIFORM PANTS (no refund will be issued if the students cannot go on the trip due to uniform violation)**

**MUST PAY THE ABOVE AMOUNT, IN FULL, BY OCTOBER 3, 2018.**

**THE PERMISSION SLIP AND THE PAYMENT MUST BE SUBMITTED IN PERSON AT THE SAME TIME**

You should also be advised that this payment is non-refundable if your son/daughter cancels the trip participation and no substitute student can be found to take and pay for said trip in his/her place. Parent must chaperone students ineligible due to SIS points but would like to go.

Furthermore, please be informed that it is the policy of the Board of Education of Prince George's County that no student is denied the opportunity to participate in a Field Trip for reasons of inability to pay. Accordingly, if you desire to have your son/daughter participate in said Field Trip but are unable to pay please call the school at your earliest opportunity.
