CONFIRMED CASE

(POSITIVE COVID-19 TEST)

Recommendation for Person with COVID-19 Symptoms

May return when it has been at least 10 days since symptoms first appeared AND no fever for at least 24 hours without fever-reducing medication AND improvement of other symptoms. If asymptomatic when tested may return when it has been at least 10 days since the date of the test. Prince George's County Health Department will provide a release to return to work for all confirmed cases.

Quarantine of Close contacts Not Fully Vaccinated

7-Day Quarantine can be utilized if all the following criteria are met: **Maintain strict adherence to ALL mitigation strategies**, daily symptom monitoring continues through day 14, and the person remains asymptomatic the entire duration of quarantine. The school is responsible for verifying a negative COVID-19 PCR test that was obtained on day 5 or later of quarantine for:

- Student: The parent must monitor and ensure daily that their child is asymptomatic on day 7 for return to school on day 8. Daily symptom monitoring by the parent must be performed to ensure they remain asymptomatic through day 14.
- Staff must self-monitor daily to ensure you are asymptomatic on day 7 for return to work on day 8. Daily symptom monitoring must continue through day 14.

Notes:

- Failure to test will result in a 10-day quarantine.
- Those under 5 years of age must guarantine for the full 14 days.
- Those who are unable to wear the mask correctly and consistently must quarantine for the full 14 days.

Quarantine of Close Contacts Fully Vaccinated

Fully vaccinated close contacts who are asymptomatic do not need to quarantine. It is recommended to get tested 5 days after the last date of exposure and wear a mask for 14 days. If the test is positive on day 5, follow the Confirmed Case guidelines.

Notes: PGCPS currently has a mask mandate in place and must be adhered to.
