Dear Parent:

This is to inform you that **CMIT South Middle School** Students will be taking a Field Trip to **Skate Zone, Crofton, MD** on **January 9, 2019**. The purpose of this trip is to take part in a STEM program where students will learn about engineering, friction, and design in terms of roller-skating and apply that knowledge to complete various activities. The field trip seats are on a first come, first serve basis. We have 100 student seats available. Students intending to participate in said field trip are expected to assemble at the school by **8:20 am**. Students will return to school **no later than 3:00 pm**. Transportation will be provided by a commercial carrier. The commercial carrier will be **Dillon's Bus Company**.

The cost for each participating student is **\$32.00** to cover admission and all you can eat lunch and transportation. Permission slips and payments will be collected **Monday, January 7th and Tuesday, January 8th during lunch periods only**. Payments may be made via cash (**exact change is needed**), money order or check (made out to CMIT South). Students **will not need to pay for lunch, as it is included in the price (pizza and beverage)**. Only students with specific dietary needs can bring a bagged lunch but this does not affect the field trip cost. Students are allowed to bring additional money for other expenses.

REQUIREMENTS TO ATTEND

- MUST NOT HAVE LOST MORE THAN 15 SIS POINTS BETWEEN DECEMBER 4, 2018 AND JANUARY 4, 2019.
- NO LEVEL III OR IV DISCIPLINARY VIOLATIONS DURING THE PERIOD PRIOR TO THE TRIP
- MUST WEAR THEIR CMIT SOUTH PE UNIFORM AND SOCKS (no refund will be issued if the students cannot go on the trip due to uniform violation)
- MUST PAY THE ABOVE AMOUNT, IN FULL, BY JANUARY 8, 2019.

You should also be advised that this payment is non-refundable if your son/daughter cancels the trip participation and no substitute student can be found to take and pay for said trip in his/her place. **Parents must chaperone students ineligible due to SIS points but would like to go**. Payment for chaperones is due at the time the permission slip is turned in. Please make sure you are eligible to chaperone.

Furthermore, please be informed that it is the policy of the Board of Education of Prince George's County that no student is denied the opportunity to participate in a Field Trip for reasons of inability to pay. Accordingly, if you desire to have your son/daughter participate in said Field Trip but are unable to pay please call the school at your earliest opportunity.
